ACCEPTABLE USE GUIDELINES & PARTICIPATION FORM

Middletown Public Schools is offering i-Parent as a means to further enhance communication with parents and to further promote educational excellence. i-Parent allows parents to view their own child's school records anywhere, anytime. In response for the privilege of accessing the site, every parent is expected to act in a responsible, ethical and legal manner. i-Parent is available to every parent or guardian of a student enrolled in Middletown Public Schools. Parents are required to adhere to the following guidelines:

1. Parents will not share their password with anyone.
2. Parents will not attempt to harm or destroy data of their own children, of another user, school or district network or the Internet.
3. Parents will not use i-Parent for any illegal activity, including violation of Data Privacy laws. Anyone found to be violating laws will be subject to civil and/or criminal prosecution.
4. Parents will not access data or any account owned by another parent. Parents who identify a security problem with i-Parent must notify Middletown Public Schools Technology Office without demonstrating the problem to anyone else.
5. Parents who are identified as a security risk to i-Parent or any other Middletown Public Schools' systems, computers or networks, will be denied access to i-Parent.

User guidelines and system requirements are included in the Middletown Public Schools i-Parent Information Guide. Please review the brochure before signing and returning this document. It is only by signing and returning the agreement that you will receive access to i-Parent for your child. (Within a month of receipt of this form your account information will be emailed or mailed directly to the information provided below.)
